LevelUp: We develop candidates from overlooked backgrounds with the motivation and grit to become cyber professionals. LevelUp Training courses are designed for adults to be able to maintain their current job and busy lifestyles while pursuing a career in cybersecurity. Our Instructor-Led training class is a 6-month course that meets 1 night per week and is 100% virtual. The class focuses on CompTIA Security+ curriculum, hands-on-labs, and professional development. Candidates earn their Security+ certification at the end of the class. In 2025, 129 candidates enrolled in LevelUp Training with a total of 16,250 training hours completed.

Share experiences and advice with future professionals. In 2025, 889 students were "ignited" through PowerUp.
